This letter is to notify you of the filing of the Preliminary Claimants List in which you may be a potential class member. DEFENDANTS'NOTICE OF FILING
OF THE PRELIMINARY CLAIMANT
LIST

NOW COMES Matthew S. Sullivan, as counsel for the Defendant Class, and pursuant to that Settlement Agreement ("Agreement") and Court Order approving the Agreement, files the Preliminary Claimant List. In support of this filing, the undersigned shows unto the Court as follows:

- 1. Pursuant to paragraph 4 of the Agreement, the undersigned caused to be published certain information relating to a Claims Procedure for the Eliza Diamond Class Action.
- 2. The Claims Procedure required that any person contending they were an heir of Eliza Diamond and entitled to participate in the settlement, had to file a Notice of Claim and then a Proof of Claim with supporting documentation.
- 3. That Notice of Claims were submitted in a timely fashion and those individuals received additional information and instructions regarding the completion of the Proof of Claim. The correspondence for the Proof of Claim that contained instructions is attached hereto as Exhibit A.
- 4. The undersigned, despite the language of paragraph 4 of the Agreement regarding untimely submissions and those individuals being barred, provided information and instructions to a claimant that provided a Notice of Claim after the filing deadline. That individual has a notation of "late entry."

- 5. The Deadline for Filing the Proof of Claim and any supporting documentation ran on May 9, 2015. Pursuant to Paragraph 6 of the Agreement, the undersigned is providing to the Court this Preliminary Claimant list within thirty (30) days.
- 6. In an effort to assist the Court with the claims process, and in some instances confusing and overlapping information, the Preliminary Claimant list is broken down into claimants falling under one of the seven children of Eliza Diamond, all of whom were identified in the Referee's Report. Those seven children are: Mary Jane Moore, John Allen More, William Thomas Moore, Hezekiah Moore, Millie Moore, William David Moore, and Betsy Williams.
- 7. Each claimant falls under one of the seven children. The claimants are then divided as set forth in Paragraph 6 of the Agreement; specifically the claimants are listed as either: (a) a list of claimants who have satisfied the filing requirements (Completed claims); (b) a list of claimants who have filed a claim with an affidavit and/or other supporting documents; and (c) a list of conflicting (Incomplete) claims with supporting documents. Additionally, there is a notation as to each claimant, as to whether he/she is eligible to participate as to Tract 1 and/or Tract 2.
- 8. The undersigned provided considerable liberty with the information to be considered an "affidavit". The undersigned accepted as an affidavit, any statement with supporting information that might otherwise be used to document a family relationship to Eliza Diamond or any person identified in the Referee's Report.
- 9. The undersigned has grouped any claimant that submitted a claim that did not fall within the first two categories within the "conflicting" or "incomplete" category. It should be noted that these claims may not be "conflicting," but in some instances just incomplete. By way of example, there are a number of claimants who failed to provide certain information. The undersigned did not nor could not determine whether that person should or should not be included within the class.
- 10. Any claim that is listed in the "conflicting" category has a notation of what information may be needed to complete the claims process or an indication as to why that claimant may not be a class member.
- 11. The undersigned attempted to provide the broadest latitude to permit claims. For example, there are individuals

who failed to submit claims under additional heirs for whom they are eligible to participate. In that regard, those individuals may be listed twice. Those claimants may be included under two categories: "completed" as to one heir and "conflicting" as to another heir.

- 12. The Preliminary Claimant List for Mary Jane Moore Descendants including a list of claimants with completed claims process, claimants relying on affidavits or other supporting information and a list of conflicting claims is attached as Exhibit B.
- 13. The Preliminary Claimant List for John Allen Moore Descendants including a list of claimants with completed claims process, claimants relying on affidavits or other supporting information and a list of conflicting claims is attached as Exhibit C.
- 14. The Preliminary Claimant List for William Thomas Moore Descendants including a list of claimants with completed claims process, claimants relying on affidavits or other supporting information and a list of conflicting claims is attached as Exhibit D.
- 15. The Preliminary Claimant List for Hezekiah Moore Descendants including a list of claimants with completed claims process, claimants relying on affidavits or other supporting information and a list of conflicting claims is attached as Exhibit E.
- 16. The Preliminary Claimant List for Millie Moore Descendants including a list of claimants with completed claims process, claimants relying on affidavits or other supporting information and a list of conflicting claims is attached as Exhibit F.



Notice of Claim T.

To qualify as a Claimant, an individual must file the following, in writing, with Class Counsel:

- full name;
- mailing address;
- telephone number;
- name of person identified in the Referee's Report¹ as an "Owner" through whom the Claimant is claiming;
- brief explanation of Claimant's basis for claim (e.g., child of Owner named in Referee's Report); and
- proof of identity (e.g., government issued photo identity).

In addition, each Claimant is encouraged to provide Class Counsel with an email address for ease in communication and to reduce the cost of communicating with Class Counsel.

Each Claimant is responsible for promptly notifying Class Counsel in writing of any change to the first three items of information required by this Notice of Claim section as well as the Claimant's email address, if provided. All Court-ordered notifications sent to either the last email or mailing address provided by the Claimant shall be deemed sufficient and Class Counsel shall be under no obligation to attempt any other notification to such Claimant.

Failure to provide the above information by March 6, 2015, the Deadline for Filing Notice of Claim established by the Court, will bar the individual from participating as a Claimant.

On or before May 6, 2015, the Deadline for Filing Proof of Claim established by the Court, each Claimant who has timely filed a Notice of Claim must provide the following written documentation to Class Counsel. 

- B. <u>If Claimant is a child of an Owner named in the Referee's Report.</u> Claimant must provide Claimant's birth certificate showing as a parent an Owner named in the Referee's Report.
- C. If Claimant is a grandchild, great-grandchild, or later direct descendant of an Owner named in the Referee's Report. 
